Constitution

Whereas we, being an incorporate body of people of like faith in the body of Christ:

- 1. Believe in the Lord Jesus Christ for eternal life through His death and the power of His resurrection.
- 2. Believe the Bible to be God's word and the revelation of His will to man and accept it as our rule for faith and conduct.
- 3. Belief in Christian fellowship, mutual edification and evangelical effort, in the form of local churches, is God's ordained order for His people.
- 4. Believe each church is to assemble together for worship, fellowship, counsel, and instruction in the Word of God, and the work of the ministry
- 5. Believe God has called and anointed us to emphasize the fullness of the
- 6. Therefore, we have accepted and adopted the following Statement of Fundamental Truths and Constitution. We shall seek, by the grace of God, to be governed by the Constitution as set forth, and will also seek to teach and propagate the doctrines contained in the Statement of Fundamental Truths.

Statement of Fundamental Truths

- 1. **The scripture inspired**. The Bible is the inspired Word of God, a revelation from God to man, the infallible rule of faith and conduct, and is superior to conscience and reason, but not contrary to reason (2 Timothy 3:15, 2 Timothy 3:16, 1 Peter 2:2).
- 2. **The one true God**. The one true God has revealed himself as the eternally self-existent, self-revealed "I AM" and has further revealed Himself as embodying the principles of relationship and association, i.e., Father, Son, and Holy Spirit (Deuteronomy 6:4, Mark 12:29, Isaiah 43:10, Isaiah 11, Matthew 28:19).
- 3. **Man, his fall and redemption**. Man was created good and upright for God said, "Let Us make man in our image, after our likeness." But man, by voluntary transgression, fell and his only hope of redemption is in Jesus Christ the Son of God (Genesis 1:26-31, Genesis 3:1-7, Romans 5:12-21).
- 4. The salvation of man.
 - 1. Conditions of Salvation. The grace of God, which brings salvation, has appeared to all men, through the preaching of repentance toward God and faith toward the Lord Jesus Christ; the washing of regeneration and the renewing of the Holy Spirit, and being justified by hope of eternal life (Titus 2:11, Romans 10:13-15, Luke 24:47, Titus 3:5-7).
 - 2. Evidence of salvation. The inward evidence to the believer of his salvation is the direct witness of the spirit (Romans 8:16). The outward evidence to all men is a life of righteousness and true holiness.
- 5. **Baptism in water**. The ordinance of baptism by a burial with Christ should be observed as commanded in the scriptures by all who have repented and believed in Christ as Savior and Lord. In so doing, they have the body washed in pure water as an outward symbol of cleansing, while their heart has already been sprinkled with the blood of Christ as in inner cleansing. They declare to the world that they have died with Jesus and been raised with Him to walk in newness of life (Matthew 28:19, Acts 10:47, Acts 48, Romans 6:4, Acts 20:21, Hebrews 10:22).
 - The Lord's supper. The Lord's supper, consisting of the elements, bread and the fruit of the vine, is the symbol expressing our sharing the divine nature of our Lord Jesus Christ (2 Peter 1:4), a memorial of His suffering and death (1 Corinthians 11:26), a prophecy of His second coming (1 Corinthians 11:26), and is enjoined on all believers until He comes.
 - 7. **Regeneration**. All people who turn from their sins and put their faith in the finished work of Jesus Christ receive a new birth by which their life is regenerated by the power of God's Holy Spirit (John 3:3-6, Titus 3:5). From that time forth the regenerated person has God's Holy Spirit dwelling within them enabling them to live a holy life (1 Corinthians 3:16, 2 Peter 1:3-4). Also giving them power to be witnesses for Jesus Christ (Acts 1:8).
 - 8. **The promise of the Father.** All believers are entitled to the promise of the Father and the baptism in the Holy Spirit according to the command of our Lord Jesus Christ. This was the normal experience in the early Christian Church. With it comes a

deeper spiritual life and service, the bestowment of the gifts and their uses in the work of the ministry (Luke 24:49, Acts 1:4, 1 Corinthians 12:1-31). This wonderful experience is distinct from and subsequent to the experience of the new birth (Acts 10:44-46, Acts 11:14-16, Acts 15:7-9).

- 9. **Sanctification.** The scriptures teach a life of holiness without which no man shall see the Lord. By the power of the Holy Spirit we are able to obey the command, "Be holy, for I am holy." Sanctification is the will of God for all believers, and should be pursued by walking in obedience to God's Holy Spirit. Sanctification is experienced in basically three ways:
 - 1. The church. The church is the body of Christ, the habitation of God through the spirit with divine appointments for the fulfillment of her great commission. Each believer, born of the spirit, is an integral part of the church, which is written in heaven (Ephesians 1:22, Ephesians 1:23, Ephesians 2:22, Hebrews 12:23).
- 10. **The ministry and evangelism**. A divinely called and scripturally ordained ministry has been provided by our Lord for the evangelization of the world and the edifying of the body of Christ (Mark 16:15-20, Ephesians 4:11-13).
- 11. **Divine healing**. Deliverance from sickness is provided for us in the atonement, and is the privilege of all believers (Isaiah 53:4, Isaiah 53:5, Matthew 8:16, Matthew 8:17).
- 12. **The blessed hope**. The resurrection of those who have fallen asleep in Christ and their translation, together with those who are alive and remain unto the coming of the Lord, is the imminent and blessed hope of the Church (1 Thessalonians 4:16, 1 Thessalonians 4:17, Titus 2:12, 1 Corinthians 15:51, Romans 8:23).
- 13. **The millennial reign of Jesus**. The revelation of the Lord Jesus Christ from heaven, the salvation of national Israel, and the millennial reign of Christ on earth are the scriptural promise and the world's hope (2 Thessalonians 1:17, Revelation 19:11-14, Romans 11:26, Romans 11:27, Revelation 20:1-7).
- 14. **The lake of fire.** The devil and his angels, the beast and the false prophet, and whoever not found written in the Book of Life, shall be consigned to everlasting punishment in the lake, which burns with fire and brimstone, which is the second death (Revelation 19:20, Revelation 20:10-15).
- 15. **The new heavens and the new earth**. We, "according to His promise, look for new heavens and a new earth wherein dwells righteousness" (2 Peter 3:13, Revelation 21, Revelation 22).

BYLAWS

WALK IN FAITH MINISTRIES

For the purpose of establishing and maintaining a place for the worship and education of the one true God; to provide for Christian fellowship for those of like precious faith, irrespective of social position or worldly possessions; for the propagation of the Gospel of Jesus Christ both in home and foreign lands, this church shall be governed by the following Constitution:

ARTICLES OF INCORPORATION

ARTICLE I WALK IN FAITH MINISTRIES

As stated in the Articles of Incorporation, the name of the corporate church shall be **WALK IN FAITH MINISTRIES**

ARTICLE II PURPOSES AND POWERS

THE PURPOSES FOR WHICH THIS CORPORATION IS FORMED ARE:

1. To establish a Biblical Christian Ministry to offer bible teaching, with community outreach ministries, literature, children's ministry and all other areas deemed useful to propagate and practice the full Gospel of the Lord Jesus Christ and for its service to the community.

2.It is one purpose of this local church corporation to earnestly seek and promote the unity of God's people in the Scriptural manner of Godly love, respect and faithful voluntary cooperation with liberty. To that end it shall associate and co-operate freely with other churches and with church organizations.

3. To act as Trustee under any trust incidental to the principal objects of the corporation and to receive, hold, administer and expend funds and property subject to such trust.

4. To enter into, make, perform and carry out contracts of every kind for any lawful purpose without limit as to amount and with any person, firm, association or corporation; to draw, make, accept, endorse, discount, issue and execute promissory notes, warrants and other negotiable or transferable interests.

5. To take, purchase or otherwise acquire; to own, hold, occupy, use and enjoy, manage, improve, develop and work; to grant, sell, exchange, let, demise and otherwise dispose of real estate, buildings; and improvements, interest and estate therein without limit as to the amount thereof and wheresoever the same may be situated; to erect, construct, alter and repair buildings; to assume any and every kind of contract, agreement and obligation by or with any person, firm, corporation or association, or any Federal, State or other Government for the erection, construction, alteration, repair, renewal, equipment, improvement, development, use, enjoyment, leasing, management or control of any buildings, improvements or structures of any kind wherever the same may be situated. 6.To purchase or otherwise acquire, to own, hold, use and enjoy, to sell, assign and transfer, exchange or otherwise dispose of, deal in or deal with personal property of every kind and description without limit as to the amount thereof and wheresoever the same may be situated.

7.To borrow and to loan money and to give and to receive evidence of indebtedness and security thereof; to draw, make accept, endorse, execute, and issue promissory notes, warrants, and other debentures of the corporation, or otherwise to make guarantees of every kind and secure any or all obligations of the corporation by mortgage, trust deed or otherwise.

8. To do all other acts necessary or expedient for the administration of the affairs and attainment of the purposes of the corporation and to have and exercise all the powers now or hereafter conferred by the Laws of the State of Your State, upon non-profit corporation.

ARTICLE III

ORDINANCES

(A) The ordinance of Baptism by immersion in the Name of the Father, and of the Son, and of the Holy Ghost as commanded in the Scriptures, shall be administered to all those who have believed on the Lord Jesus Christ to the saving of their souls and who give clear evidence of their fruit (Matthew 28:19, Colossians 2:12).

(B) The ordinance of the Lord's Supper shall be observed regularly as a part of public worship, as commanded by the Lord (Luke 22:19, 20; I Corinthians 11:23-26).

(C) WALK IN FAITH MINISTRIES will provide proper training, education and equipping necessary to become properly ordained as new pastors into the church body.

(D) Infants and small children may be dedicated to the Lord in the church upon the request of the parents or guardians (Mark 10:13-16; Luke 18:15, 16).

(E) The ministry of laying on of hands accompanied with the anointing with oil, for the healing of the sick, shall be granted as a request is made and the need may require (Mark 16:18; James 5:14).

ARTICLE IV

MEMBERSHIP

Membership in WALK IN FAITH MINISTRIES shall be eligible to all who give evidence to their faith in the Lord Jesus Christ and who voluntarily hold to the fundamental doctrines of the Christian faith. When a person chooses to be a part of WALK IN FAITH MINISTRIES, and involve themselves can take the required membership steps to become a faithful member. (Ephesians 4:16). A member is one who attends regularly, serves at and contributes financially to WALK IN FAITH MINISTRIES.

Any member wishing to hold a leadership position in WALK IN FAITH MINISTRIES will be asked to sign an accountability agreement, stating that you agree to live and practice inside and outside of this church by biblical truth and as is written in these bylaws.

ARTICLE V OFFICERS

The officers of WALK IN FAITH MINISTRIES shall consist of a President, a Vice-President, and Secretary-Treasurer. There shall not be less than three (3) and no more than five (5) officers at any time. There will be an advisory board that will review and seek community needs and outreach opportunities. All decisions are the final approval of the Pastor and President. President has the authority to sign all legal documents, as long as said documents are agreed upon by the board.

PASTOR AND PRESIDENT

Section 1. Term of Office President of the Corporation shall hold this office until otherwise voted. Jodi L. Grant.

Section 2. Current Pastor **Cynthia Parker**: Vacancy of Pastorate: The vacancy shall be filled by the appointment of a new pastor by the departing pastor. If the departing pastor is not available to do so due to death or illness, this appointment will be made by the President . In some cases a Pulpit Search Committee may be selected who will search for pastoral candidates and submit them to the departing pastor and/or elders for final approval. In most cases, when able, it is best to follow the examples set forth in scripture of the person called by God (pastor or other fivefold minister) to pass the mantle on to the one God has chosen and shown him (Joshua 1, 1 Kings 19:19-21, 2 Kings 2:1-14). Imparting the anointing and call of God to the one who has already proven themselves to be faithful (2 Timothy 2:2, Luke 16:12).

Section 3. Duties of Pastor: The Pastor shall be considered the spiritual overseer of the church and shall direct all the church activities. He/she shall preside over all business meetings of the church and shall be an ex-officio member of all committees and departments.

Section 4. Support of Pastor: The Pastor shall be supported by his/her board according to his/her needs, either by free-will offerings or by stated allowance as shall be decided upon by the Directors and/or Elders in its regular business sessions.

ARTICLE VI MEETINGS

Section 1. Meetings for Worship. Meetings for public worship shall be held on each Lord's Day and during the week as may be provided for under the direction of the Pastor.

Section 2. Annual business meeting. There shall be a monthly Business Meeting of WALK IN FAITH MINISTRIES. This business meeting shall be held at the end of the fiscal year. This meeting shall be conducted to discuss all reports of past and new business. Fiscal year is March 15, - March 14.

Section 3. Special business meetings may be called at any time with far notice given. Monthly meetings with the advisory board.

Section 4. Notice of business meetings. Written notice of the date and place of the Annual Business Meeting and of any special business meetings shall be sent by regular mail or email to all active members at least ten (10) days and not more than thirty days prior to such meeting.

Section 5. Order of Business. The regular order of business for the Annual Business Meeting of WALK IN FAITH MINISTRIES shall be as follows:

- 1. Devotional.
- 2. Reading of previous minutes.
- 3. Report of the treasurer.
- 4. Report of committees.
- 5. Unfinished business.
- 6. Installation of officers.
- 7. New business.
- 8. Adjournment.

This order of business may be altered or suspended at any meeting by a majority vote of the members present. The usual parliamentary rules as laid down in "Robert's Rules of Order" shall govern all debates when not in conflict with this Constitution.

ARTICLE VII

FINANCES

- 1. All funds needed for the maintenance of WALK IN FAITH MINISTRIES shall be provided by voluntary contributions, tithes and offerings. Every member shall decide before God what he or she can cheerfully give to the support of the Lord's work at home and in the foreign field (Malachi 3:10, I Corinthians 16:1-2; Romans 12:8).
- 2. All offerings shall be counted by at least two members.
- Deposits must be made by WALK IN FAITH MINISTRIES promptly in a local bank account owned by WALK IN FAITH MINISTRIES, with 2 board members on the accounts
- 4. Annual reports will be furnished to the officers and made available to the membership.
- 5. Two signature checks are to be used, PRESIDENT AND TREASURER
- 6. The treasurer must be a board member (officer/director). However, a secretary or administrative assistant may be utilized in the day-to-day record keeping as necessary.
- 7. Financial records, without exception, are to be kept in the church office.

ARTICLE VIII DEPARTMENTS AND COMMITTEES

The church shall provide for the establishment of specific committees as needed.

ARTICLE IX PROPERTY

The Officers of WALK IN FAITH MINISTRIES shall have power to carry out all of the purposes and powers set forth in Article II. The President signature shall be sufficient certificate for negotiating any and all of the provided powers in said Articles.

ARTICLE X NOT FOR PROFIT CORPORATION

This corporation is organized pursuant to the general non-profit corporation law of the state of Pennsylvania; the property of this corporation is irrevocably dedicated to religious and charitable purposes, and upon liquidation, dissolution, or abandonment, shall not inure to the benefit of any private person except a fund, foundation, or corporation organized and operated for religious or charitable purposes.

ARTICLE XI CONDUCT OF ORGANIZATION

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the corporation shall be the carrying of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by an corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE XII ORGANIZATION OF A CORPORATION

Said corporation is organized exclusively for charitable, religious and educational purposes, including the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE XIII DISSOLUTION

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal

government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of common pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
